

## Summer Staycation Raffle Rules and Disclosure Statements

1. Sales for raffle tickets for Atlantic Canadian Irish Dance Championship (“ACIDC”) begins on May 27 and ends on June 17, 2021 (“Raffle Period”) with a draw date of June 20, 2021. The Raffle is conducted by ACIDC. The Official Rules of the Raffle are set forth herein. By entering the Raffle, Participants agree to be fully and unconditionally bound by these Official Rules, waive any right to claim ambiguity in the Raffle or these Official Rules, and further agree to be bound by ACIDC’s decisions and interpretation of these Official Rules.
2. Void where prohibited by law.
3. Eligibility:
  - a. The Raffle is open to all persons age 19 and older.
  - b. Ticket may be sold and purchased only in Nova Scotia.
  - c. All members of ACIDC organizing committee and their family members are eligible to purchase tickets.
4. Each ticket will cost \$20.00 for one entry or \$50.00 for three entries. Prizes will not be issued to anyone other than the Entrant(s) whose name is on the ticket stub.
5. Each numbered Raffle ticket stub will be placed in the Raffle ticket container.
6. Tickets will be sold via Experience Funding and online ticket retailer register with Alcohol and Gaming NS.
7. All purchasing and management of tickets will be as set out in the contract with Experience Funding.
8. ACIDC will be responsible for picking up the printed tickets from the contracted printer (Staples) and taking to the draw location with a minimum of three (3) ACIDC members present for the draw.
9. A member of the ACIDC committee will draw one ticket from the container and this will be filmed live. The ticket will be read and this will be the winner of the prize.
10. The public drawing will be on June 20, 2021 and will be official after the committee has determined that all eligibility requirements have been met.
11. Drawing Location: The public location of the draw will take place at Rising Tide Irish Dance Academy, 325 Rocky Lake Dr Unit 3, Bedford, NS B4A 2T3
12. Drawing Time: 12:00PM on June 20, 2021
13. You need not be present to win.
14. The winner will be notified by phone on June 20, 2021

16. Notification. Prize Winner will be notified by Phone and Email. A winner has 90 days to claim a prize, and every attempt has to be made to contact the winner. 17. The Prizes are provided “as is” condition with no guarantees or warranties from ACIDC. The winner is subject to relevant federal, provincial, and local taxes and other expenses. All taxes and other transfer fees in connection with any Prize are the sole responsibility of the Prize Winner. The purchase of tickets for raffles, lotteries, or similar drawings for prizes are not gifts, and do not qualify as tax deductible charitable contributions.
18. This is not a tax-deductible contribution.
19. The Raffle is subject to all applicable federal, provincial, and local laws and regulations, and is void wherever prohibited or restricted by law.
20. **The minimum number of tickets that must be sold is 36.** If the minimum number is not reached by June 17, and extension will be requested with AGD. If the raffle is cancelled because of insufficient ticket sales, ACIDC reserves all rights to refund all monies.
21. If the Raffle is cancelled because of insufficient ticket sales, refund to the purchaser of a ticket will be made as stated below.
22. Purchaser(s) will be refunded the price of the chance automatically upon cancellation of the raffle. Refunds will be provided back to the buyer’s credit card through the vendor “Experience Funding”.
23. Proceeds from the Raffle will benefit ACIDC and its ongoing activities for the purposes of hosting an Atlantic Canadian Irish Dance Championship. Contributions will go directly to ACIDC Committee and not individual committee members.

24. Odds of winning depend on the total number of Raffle Tickets sold. Odds of winning depend on number of eligible entries received.
25. General Conditions. The Raffle is subject to these Official Rules. These Official Rules shall not be changed by any oral statement made by any employee or other person acting on behalf of ACIDC. By participating, Entrants agree: (i) to be bound by these complete Official Rules and the decisions of ACIDC which shall be final and binding; and (ii) to waive any right to claim ambiguity in the Raffle or these Official Rules, except where prohibited by law. By accepting a Prize, Winner agrees to release Atlantic Canadian Irish Dance Championship (ACIDC), its officers, directors, employees, representatives and agents, and any person or entity associated with the production, judging, or administration of the Raffle (collectively, the "Releases") from and against any claims, damages, disability, attorneys' fees, and costs of litigation and settlement, as well as any liability due to any injuries, damages or losses to any person (including death) or property of any kind resulting in whole or in part, directly or indirectly, from redemption, acceptance, possession, ownership, misuse or use of any prize or participation in any Raffle - related activity or participation in this Raffle. Except where prohibited by law, the Winner of the Raffle Ticket and acceptance of the Grand Prize constitutes permission for ACIDC to use said Winner's name, photograph, likeness, statements, biographical information, voice, and city and state address for promotional or advertising purposes in connection with this Raffle on a worldwide basis, and in all forms of media, now or hereafter known, in perpetuity, without review, permission or further compensation. All Federal, Provincial and Local Taxes associated with receipt or use of the Grand Prize, including without limitation all applicable sales, use, luxury, income and special taxes are the sole responsibility of the winner. Winner must claim prize with ACIDC, and sign and deliver a completed Release Form at the time of settlement. ACIDC, reserves the right to disqualify false entries or entries suspected of being false, and any illegible, defective, incomplete or physically altered entry form and entries that do not include valid or complete payment. ACIDC is not responsible for printing errors in any drawing-related material, or for lost, late, misdirected or non-delivered mail, or any other failure to receive orders or delivery receipts prior to the drawing deadline. All sales are final unless otherwise specified in these official rules. ACIDC will reject any drawing ticket request if the payment is not honored or is returned due to insufficient funds or any other reason prior and not remedied within (7) days before the drawing. Correction of any such return or non-payment is the sole responsibility of the ticket purchaser. All entries become the property of ACIDC and will not be returned. ACIDC reserves the right to disqualify any entrant if it finds to be tampering with the entry process or the operation of the Raffle or violating these Official Rules, and reserves the right to cancel the Raffle should it suspect fraud or for reasons out of the control of ACIDC.
